- 4. You should maintain a GPA of 3.0 or better;
- 5. You will be asked to provide two (2) letters of recommendation from advisors or instructors at the time of interview.
- If selected and offered an internship position under the program, final consideration will be subject to:
  - 6. A satisfactory Police and Court clearance
  - 7. A satisfactory Drug Screening
  - 8. A satisfactory review of your credit report
